## What are the New Water Rules for Glenn County Residents?

## All Californians:

- No outdoor irrigation during & 48 hours following measurable precipitation.
- Don't use potable water in decorative water features that do not recirculate the water.
- Don't use hoses without shutoff nozzles to wash cars.
- Don't allow runoff when irrigating with potable water.
- Don't use potable water to wash sidewalks & driveways.
- Don't use potable water to irrigate ornamental turf on public street medians.
- Don't use potable water to irrigate landscapes of new homes & buildings inconsistent with CBSC & DHCD requirements.

State Water Resources Control Board Emergency Conservation Regulation (5/18/15)

Additionally, water suppliers (i.e. City of Orland and Cal Water) are responsible for achieving designated conservation standards (4%-36%), notifying customers about leaks that are within the customer's control and reporting on water use, compliance & enforcement.

## **Orland Residents:**

- No water budget per household but community together must reduce water use 25% June-Nov 2015 compared to same period 2013.
- Lawn irrigation is limited to no more than 3 days per week and only between 8:00 p.m. and 8:00 a.m. on those days.
- Residents north of State Route 32 may irrigate landscapes only on Sundays, Wednesdays and Fridays.
- Residents south of State Route 32 may irrigate landscapes on Saturdays, Tuesdays and Thursdays.
- No lawn irrigation is allowed on Mondays.
- Leaks must be repaired promptly.
- No permits to drill new private wells will be approved.

## Willows & Hamilton City Residents:

- Comply with water budget to achieve a 28% (Willows) or 32% (Hamilton City) monthly reduction in water use from 2013 average monthly water use.
- Landscape irrigation is limited to no more than 3 days per week and only between 6:00 p.m. and 8:00 a.m. on those days.
- Addresses ending in an odd number may irrigate landscapes only on Sundays, Wednesdays and Fridays.
- Addresses ending in an even number or residences with no address may irrigate landscapes only on Tuesdays, Thursdays and Saturdays.

\*Please don't let trees die. The primary target for urban water use reduction is ornamental lawns.
