### **Livestock Judging 101**

#### **Appeal of Council Policy**

At a regular scheduled meeting or by special meeting requests, individuals may appeal decisions or policies. Requests must be submitted in writing within 15 days of the incident to the county 4-H staff, preferably using the County 4-H Complaint Form. Youth and parent/guardian must attend the appeal process. Based on confidentiality or urgency the Executive Committee, a 4-H Staff appointed to the Review Committee or County Council shall be the governing body to hear the appeal and make a final decision. If Council, only one vote per club, and 51% of the clubs must be represented with a plurality of the votes casts to determine the final decision.
