# **Environmental Stewardship Shortcourse** (ESSC 1) Scheduled April 17, 22, 24, 2002

A series of the Environmental Stewardship Shortcourse for dairy producers has been scheduled for April 17, 22, and 24, 2002.

All classes will be held from 1:00 p.m. to 3:00 p.m. at the Glenn County Cooperative Extension Office, 821 E. South Street in Orland.

Some of the topics to be discussed will include:

- estimating needed storage for liquid manure
- developing a storm water pollution prevention plan
- learning to sample manure sources for nutrient content
- estimating average nutrient application to land
- estimating existing liquid manure storage capacity

The class is offered at no cost to dairy producers in three two-hour sessions, and producers are encouraged to ask questions and participate in discussions. Because the ESSC certification is linked to the California Dairy Quality Assurance program, the same representative from the dairy should attend all three classes.

If you have attended classes previously, but didn't complete all three, now is the time to attend the class you missed. Individuals will receive a certificate of participation when they have attended all three classes, and classes need not be attended in sequence.

Producers wishing to take this class MUST pre-register by April 12, 2002. The class will be canceled unless dairy producers make advance reservations to attend.
