#### **Important Misc. Fair Information**

systems for the hogs available. You will also be able to use nozzles for washing the hogs. If you wish to use them, you must bring your own liksit and/or nozzle.

#### **Animals & Drugs: Take Note!**

If you are bringing an animal to the Glenn County Fair—remember that no unauthorized chemicals can be used which would cause the carcass to fail USDA and Food & Drug Administration standards. This *also includes* the use of steroids! Be sure that the withdraw time required of any medication, including medicated feed or pesticides are followed.

If drug residue is detected, you can be liable to the buyer for an amount equal to**three times the purchase price** and may also be liable for **attorney's fees and civil penalties.** 

#### **Code Of Conduct For All Exhibitors**

There will be rules of conduct that exhibitors and leaders are expected to adhere to again this year. These will be posted in the livestock area and provided to exhibitors. Exhibitors must sign a code of conduct and turn it in before your animals are brought to the fair.

#### **Livestock Leader and Vehicle Passes**

Feeding passes issued are for the vehicle only. The driver and any passengers must have either a season ticket, daily ticket or a wrist band. Vehicles will be allowed on grounds from 6:00 a.m. to 10:00 a.m. for daily feeding only. After 10:00 a.m., vehicles must be moved to the parking lot or they will be towed. For more details, please refer to the premium book. The South Street vehicle gate, across from Fairview School, will be open 24 hours a

day.

#### **Wild Steer Policy**

You may be asked to remove your steer from the grounds by agreement of the Fair Manager, Livestock Superintendent and Beef Superintendent if you are unable to control your steer at the fair. For the safety of fair goers and exhibitors, it is mandatory that you can control your steer.


Action Plan that outlines what their county needs to do in their local community to address local issues through community action after the conference.




